Tournament Rules

1. All Federal, State and Local laws are to be observed at all times.
2. Tournament will be held regardless of weather. No refund of entry fees.
3. Trailering will be allowed. You may launch from any ramp after 4:30 a.m. **DO NOT START FISHING BEFORE 6:00 A.M. YOU MUST STOP FISHING ON OR BEFORE 2:00 P.M.** Registration at Yarborough Landing will open at 5:00 a.m. on the day of tournament for those not registered in advance.
4. All fish must be 16 inches long. Only Large Mouth, Kentucky or Spotted Bass (Black Bass) will be weighed. Each contestant must weigh their own fish. No live bait will be allowed and fish must be caught with artificial lures, jigs or prepared pork rind with rod and reel only. No trolling is permitted. **NO DEAD FISH WILL BE WEIGHED.** All fish will become the property of Tri-County Bass Club and will be treated and released.
5. **ALL TIES WILL BE DETERMINED BY THE FIRST FISH WEIGHED.**
6. Sportsmanship, courtesy, safety and conservation is expected from each contestant, you must have permission to fish within 50 feet of another contestants boat.
7. Contestants are required to wear a life preserver when the combustion engine is running above idle speeds.
8. Protest must be in writing and submitted to the Tournament Director no more than 15 minutes after the 2:30 cutoff time. **ALL FISHING MUST CEASE AT 2:00 P.M.** The Tournament rules committee may alter or add to these rules with the provision that any and all such changes be made clear to each contestant. Decisions of the judges and tournament officials will be final.
9. **ALL** contestants must be willing to submit to a polygraph test. Failure to submit to or fail a polygraph will result in disqualification.
